

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Department of Health and Human Services, Division of Family Assistance - FY09
Tribal Food Distribution Program Budget Amendment #1 - Account No. 01-1315)

RESOLUTION NO. 09-386

1 **WHEREAS, by Resolution Number 07-588, the Tohono O'odham Legislative Council approved the**
2 **FY2009 Food Distribution Program Tribal budget in the amount of \$79,059.63; and**

3 **WHEREAS, the Nation was notified of the final grant award for USDA budget which funding**
4 **requirement is at a 75% match by USDA and a 25% match by Tribal funds; and**

5 **WHEREAS, the Tribal match has decreased from \$79,059.63 to \$78,229.63, a decrease of \$830.00;**
6 **and**

7 **WHEREAS, the Executive Branch developed and obtained committee approval for the Department**
8 **of Health and Human Services, Tribal Food Distribution Program Budget Amendment**
9 **#1 which decreases the Food Distribution Program Tribal funding by \$830.00 and**
10 **decreases line item 770 - RM Equipment by \$500.00, and line item 771 - RM Equipment**
11 **by \$330.00 to be effective October 01, 2008 through September 30, 2009, and requests**
12 **authorization to expend these funds.**

13 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
14 **approve Budget Amendment #1 which decreases the Food Distribution Program Tribal**
15 **funding by \$830.00, from \$79,059.63 to \$78,229.63 and decreases line item 770 - RM**
16 **Equipment by \$500.00, and line item 771 - RM Equipment by \$330.00 to be effective**
17 **October 01, 2008 through September 30, 2009.**

18 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
19 **Chairperson and any designated official to expend and administer the budget as**
20 **attached, provided that any amendments affecting the funds or funding level shall be**
21 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 7TH. Day**
23 **of JULY, 2009 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0- AGAINST;**
24 **-0- NOT VOTING; and [-0-] ABSENT, pursuant to the powers vested in the Council by Section 1 (d)(2)**
25 **(3) & (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
26 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
27 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
28 **Stat. 984).**


