

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving the Department of Health and Human Services, Division of Family Assistance - FY09**  
**Tribal Low Income Home Energy Assistance Program (LIHEAP), Account No. 01-1310)**

RESOLUTION NO. 09-387

1 WHEREAS, by Resolution Number 08-710 the Tohono O'odham Legislative Council approved the  
2 Tribal Low Income Home Energy Assistance Program budget in the amount of  
3 \$100,800.00; and

4 WHEREAS, the budget authorization period for the Tribal LIHEAP is from October 01, 2008  
5 through June 30, 2009; and

6 WHEREAS, the Department of Health and Human Services, Family Assistance Division, Tribal  
7 LIHEAP is requesting that the funding period be extended from July 01, 2009 to  
8 September 30, 2009; and

9 WHEREAS, the Executive Branch developed and obtained committee approval of the Family  
10 Assistance Division, Low Income Home Energy Assistance FY 09 Tribal Budget  
11 Amendment No. 1 which extends the budget period from October 01, 2008 through  
12 June 30, 2009; to October 01, 2008 through September 30, 2009 with no change in the  
13 budgeted amount of \$100,800.00.

14 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby:

- 15 1. Approves to extend the budget period from October 01, 2008 through June 30, 2009;  
16 to October 01, 2008 through September 30, 2009 with no change in the budgeted  
17 amount of \$100,800.00

18 BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the  
19 Chairperson and any designated official to expend and administer the budget as  
20 attached, provided that any amendments affecting the funds or funding level shall be  
21 submitted for further prior approval by the Tohono O'odham Legislative Council.

22 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 7<sup>TH</sup>. Day  
23 of JULY, 2009 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0- AGAINST;  
24 -0- NOT VOTING; and -0- ABSENT, pursuant to the powers vested in the Council by Section 1 (d)(2)(3)  
25 & (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono  
26 O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -  
27 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48  
28 Stat. 984).


