

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the use of Carry Forward Funds of the US Department of Homeland Security, State of Arizona Department of Homeland Security, 2007 State Homeland Security Grant for \$23,839.51, Grant #2007-GE-T7-0006)**

RESOLUTION NO. 09-389

1 **WHEREAS, the United States Department of Homeland Security has distributed grants to**
2 **counties, through their respective states, to fund equipment purchases and training**
3 **by departments that provide public safety services within their respective**
4 **jurisdictions; and**

5 **WHEREAS, Indian tribes have been designated to receive funds through the respective state,**
6 **requiring tribes to sign a Letter of Offer and Acceptance; and**

7 **WHEREAS, the Tohono O'odham Nation has negotiated a Letter of Offer and Acceptance with the**
8 **State of Arizona for the purpose of obligating and distributing funds from the U.S.**
9 **Department of Homeland Security, Homeland Security Grant Program on a**
10 **reimbursement basis for SWAT training; and**

11 **WHEREAS, the Tohono O'odham Nation has been awarded a grant from the State of Arizona,**
12 **Department of Homeland Security in the amount of \$72,100.00 as part of the 2007 State**
13 **Homeland Security Program Grant No. 2007-GE-T7-0006 for the purchase of specific**
14 **equipment needed for enhancing the Tohono O'odham Nation Police Department**
15 **SWAT Program; and**

16 **WHEREAS, that the Tohono O'odham Legislative Council approves the use of carry forward of**
17 **unexpended funds of \$23,839.51 has been reviewed by the Grants & Contracts**
18 **Department, Executive Office, Domestic Affairs Committee and Budget & Finance**
19 **Committee, of which all recommend acceptance of the grant award by the Legislative**
20 **Council.**

21 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves carry**
22 **forward funds of the 2007 State Homeland Security Program Grant No. 2007-GE-T7-**
23 **0006 in the amount of \$23,839.51 on a reimbursement basis from the Tohono O'odham**
24 **Nation General Fund for the SWAT Training.**

25 **BE IT FURTHER RESOLVED that the line number 721 Supplies Other, will be deleted and replaced**
26 **by 810 Professional Services.**



3 **12/31/09 and with any extension of time reasonably necessary which are approved by**
4 **the granting agency, to be brought back to the Tohono O'odham Legislative Council**
5 **for approval.**


6 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
7 **Nation's Office to wit; the Chairman, Vice-Chairman and any designated official are**
8 **authorized to negotiate and execute the grant, provided however, that any**
9 **amendments affecting the funding or funding levels of the grant shall be submitted**
10 **for further prior approval.**

11 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 8TH. Day**
12 **of JULY, 2009 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0- AGAINST;**
13 **-0- NOT VOTING; and [0] ABSENT, pursuant to the powers vested in the Council by Article VI Section**
14 **1 (d)(2) & (f) of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**
15 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**
16 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
