RESOLUTION NO. 09-390

1 **WHEREAS, the United States Department of Homeland Security has distributed grants to**
2 **counties, through their respective states, to fund equipment purchases and training**
3 **by departments that provide public safety services within their respective**
4 **jurisdictions; and**

5 **WHEREAS, Indian tribes have been designated to receive funds through the respective state,**
6 **requiring tribes to sign a Letter of Offer and Acceptance; and**

7 **WHEREAS, the Tohono O'odham Nation has negotiated a Letter of Offer and Acceptance with the**
8 **State of Arizona for the purpose of obligating and distributing funds from the U.S.**
9 **Department of Homeland Security, Office of Domestic Preparedness, 2007 Homeland**
10 **Security Program, Grant No. 2007-GE-T7-0006 on a reimbursement basis to finance the**
11 **Training and Exercise Program for homeland security; and**

12 **WHEREAS, the Tohono O'odham Nation has been awarded a grant from the State of Arizona,**
13 **Department of Homeland Security in the amount of \$31,693.00 as part of the 2007 State**
14 **Homeland Security Program Grant No. 2007-GE-T7-0006 for the Training and Exercise**
15 **Program for the Office of Emergency Management; and**

16 **WHEREAS, the 2007 State Homeland Security Program Grant No. 2007-GE-T7-0006 award of**
17 **\$31,693.00 has been reviewed by the Office Grants & Contracts, Executive Office,**
18 **Domestic Affairs Committee and Budget & Finance Committee, of which all**
19 **recommend acceptance of the grant award by the Legislative Council.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves and**
21 **accepts the grant award of \$31,693.00 on a reimbursement basis from the Tohono**
22 **O'odham Nation General Fund.**

23 **BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council authorizes the Office of**
24 **Emergency Management to expend funds from this grant during award period of**
25 **09/01/07 to 12/31/09 and with any extensions of time reasonably necessary which are**
26 **approved by the granting agency, to be brought back to the Tohono O'odham**
27 **Legislative Council for Approval.**

28 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
29 **Nation's Officials to wit; the Chairman, Vice-Chairman and any designated official are**

amendments affecting the funds or funding levels of the grant shall be submitted for further prior approval.
