

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Budget Amendment No. 2 to FY 2009 Motor Pool Budget Account 01-1055)

RESOLUTION NO. 09-394

1 **WHEREAS, the Tohono O'odham Legislative Council approved the FY 2009 Motor Pool Budget**
2 **Account No. 01-1055 pursuant to Legislative Council Resolutions No. 08-265 and No. 08-**
3 **543; and**

4 **WHEREAS, the Motor Pool submitted for review and approval FY 2009 Budget Amendment**
5 **Number 2 for Budget Account No. 01-1055; and**

6 **WHEREAS, the budget is amended to increase line items 721 Supplies –Other by \$1,000.00; 723**
7 **Uniforms by \$1,000.00; 770 RM Equipment by \$9,000.00; and 771 RM Vehicles by**
8 **\$6,549.85 and decreasing line item 750 Capital in the amount of \$17,549.85 to provide**
9 **for additional operational costs for supplies, uniforms and repair and maintenance;**
10 **and**

11 **WHEREAS, the budget is also amended to change the narrative for line item 750 Major Capital**
12 **Equipment to pay for only the fuel system at an estimated cost of \$118,000.00; and**

13 **WHEREAS, the FY 2009 Motor Pool Budget Amendment Number 2 for Account No. 01-1055 has**
14 **been presented to the Budget and Finance Committee.**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
16 **approves the Motor Pool Budget Amendment Number 2 to increase line items 721**
17 **Supplies – Other by \$1,000.00; 723 Uniforms by \$1,000.00; 770 RM Equipment by**
18 **\$9,000.00; and 771 RM Vehicles by \$6,549.85 and decreasing line item 750 Major**
19 **Capital Equipment in the amount of \$17,549.85 to provide for additional operational**
20 **cost for supplies, uniforms and repair and maintenance.**

21 **BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that it hereby approved**
22 **changing the narrative for line item 750 Major Capital Equipment to pay for only the**
23 **fuel system at an estimated cost of \$118,000.00.**

24 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
25 **Official, to wit; the Chairman, Vice-Chairman and any designated official are**
26 **authorized to administer the amended FY 2009 Motor Pool Budget, provided however,**
27 **that any further amendments affecting the funds or funding levels of the budget shall**
28 **be submitted for further prior approval by the Tohono O'odham Legislative Council.**
