and Burnham)**


RESOLUTION NO. 09-396

1 **WHEREAS, by Resolution No. 09-201 the Nation approved an Attorney Contract in the amount of**
2 **\$20,000.00 with the law firm of Gammage and Burnham, P.L.C., funded by an Office of**
3 **Attorney General budget amendment approved by Resolution No. 09-160; and**
4 **WHEREAS, the Attorney General recommends approval of Amendment No. 1 to the Attorney**
5 **Contract, which adds \$100,000.00 to the budget for the Attorney Contract; and**
6 **WHEREAS, the Domestic Affairs and Budget and Finance Committees have reviewed Amendment**
7 **No. 1 to the Attorney Contract and recommend approval by the Legislative Council.**
8 **NOW, THEREFORE, BE IT RESOLVED that:**

- 9 **1. The Tohono O'odham Legislative Council hereby Approves Amendment No. 1 to the**
10 **Attorney Contract with the law firm of Gammage and Burnham, P.L.C., which adds**
11 **\$100,000.00 to the budget for the Attorney Contract, substantially in the form**
12 **attached hereto.**
13 **2. Funding for Amendment No. 1 to the Attorney Contract will come from the**
14 **\$220,000.00 for professional services approved and appropriated by Resolution No.**
15 **09-160 as Amendment No. 1 to the budget of the Office of Attorney General.**
16 **3. The Chairperson of the Nation is authorized and directed to execute Amendment**
17 **No. 1 to the Attorney Contract with the law firm of Gammage and Burnham, P.L.C.**

18 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH. Day**
19 **of JULY, 2009 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0- AGAINST;**
20 **-0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Article VI**
21 **Section 2 (a) of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**
22 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**
23 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**


