RESOLUTION NO. 09-400

1 **WHEREAS, the Child Welfare Division, Phase One Tribal Budget Account No. 01-1443 was**
2 **approved by the Tohono O'odham Legislative Council; and**

3 **WHEREAS, Child Welfare Phase One budget amendment/modification #1 is amending the budget**
4 **to include the transfer of a position from Child Welfare account 12-1313, increasing**
5 **salaries from \$484,671.63 to \$501,062.50 and fringe benefits \$155,094.92 to**
6 **\$160,340.00; and**

7 **WHEREAS, the amendment is inclusive of a new line item #864 Child Welfare Assistance in the**
8 **amount of \$103,151.36 to be used for Residential placements, Group Home**
9 **placements, Foster Care placements and clothing grants for Child Welfare clients; and**

10 **WHEREAS, the Tohono O'odham Department of Health and Human Services, Child Welfare**
11 **Division, has submitted for review and approval, budget amendment/modification #1**
12 **in the amount \$1,434,752.29.**

13 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves and**
14 **authorizes the FY 09 Child Welfare Division, Phase One budget**
15 **amendment/modification #1 in the amount of \$1,434,752.29.**

16 **BE IT FURTHER RESOLVED that the Child Welfare Division is hereby submitting budget**
17 **amendment/modification #1 to decrease line items and to revise the budget narrative**
18 **revision to establish line item #864 and to include the transfer of a position from Child**
19 **Welfare account 12-1313; increasing salaries from \$484,671.63 to \$501,062.50 and**
20 **fringe benefits from \$155,094.92 to \$160,340.00.**

21 **BE IT FINALLY RESOLVED that the Tohono O'odham Nation's officials to wit; the Chairman and any**
22 **designated official are hereby authorized to negotiate and execute the budget**
23 **provided however, that any budget amendments affecting the funds or funding levels**
24 **shall be submitted for prior approval by the Tohono O'odham Legislative Council.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08TH. Day**
26 **of JULY, 2009 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0- AGAINST;**
27 **-0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Article VI**
28 **Section 1 (d)(2) and (3) of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
29 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
30 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
31 **Stat. 984).**
