

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Amending the FY 2009 Department of Health and Human Service Title IV-B,**  
**Subparts 1 & 2 budgets for the Division of Child Welfare Services)**

**RESOLUTION NO. 09-401**

1 **WHEREAS, the Tohono O'odham Nation has historically contracted certain functions from the**  
2 **Department of Health and Human Services, Child Welfare Division to intervene**  
3 **against child abuse and neglect and to promote safe and stable families; and**

4 **WHEREAS, the Executive Branch developed and obtained Committee approval of the FY 2009 Title**  
5 **IV-B, Subparts 1 & 2 budgets, effective October 1, 2008 through September 30, 2009**  
6 **with Resolution #08-277, in the following amounts:**

- 7 1. **FY 09 Title IV-B, Subpart 1 budget = \$128,812.96**
- 8 2. **FY 09 Title IV-B, Subpart 2 budget = \$269,012.15**

9 **WHEREAS, the actual award letter for FY 2009 Title IV-B, Subpart 1 is for the amount of**  
10 **\$123,079.00, and FY2009 Title IV-B, Subpart 2 is for the amount of \$248,532.00. A**  
11 **budget amendment is needed to decrease the budget amounts.**


12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**  
13 **amend and authorize the budget amendments to reflect the decrease by \$5,733.96 for**  
14 **Title IV-B, Subpart 1 and \$20,480.15 for Title IV-B, Subpart 2 with the Indirect Cost at**  
15 **10% for Title IV-B budgets and authorizes the Executive Branch to expend funds for the**  
16 **FY 2009 Title IV-B, Subparts 1 & 2 budgets amendments attached effective October 1,**  
17 **2008 through September 30, 2009, in the amount of:**

- 18 1. **FY 09 Title IV-B, Subpart 1 budget = \$123,079.00**
- 19 2. **FY 09 Title IV-B, Subpart 2 budget = \$248,532.00**

20 **BE IT FINALLY RESOLVED that the Tohono O'odham Nation's officials to wit; the Chairman, Vice-**  
21 **Chairman and any designated official are hereby authorized to negotiate, execute, and**  
22 **expend the grant.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08<sup>TH</sup>. Day**  
24 **of JULY, 2009 at a meeting at which a quorum was present with a vote of 2,408.4 FOR; -0- AGAINST;**  
25 **187.1 NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Article VI**  
26 **Section 1 (d)(2)(3) and (f) of the Constitution of the Tohono O'Odham Nation, adopted by the**  
27 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
28 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
29 **18, 1934 (48 Stat. 984).**
