

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2009 Department of Health & Human Services, Division of Community Health
Tuberculosis Control Services Program – State Budget Amendment #1)

RESOLUTION NO. 09-404

1 **WHEREAS, the Tohono O'odham Nation has operated the Tuberculosis Control Services Program**
2 **to help prevent the spread of the disease through community education, prevention,**
3 **early detection, comprehensive regimens and careful follow-up with individuals; and**

4 **WHEREAS, the Division of Community Health, Tuberculosis Control Services Program desires to**
5 **continue the services it provides to TB susceptible and diagnosed patients; and**

6 **WHEREAS, funding for the operation of the Tohono O'odham Tuberculosis Control Services**
7 **Program has been provided in part through State and Tribal supplemental funding;**
8 **and**

9 **WHEREAS, the Tohono O'odham Nation, Division of Community Health Services through Grants**
10 **& Contracts received notification from the TB Program Manager, ADHS, that the**
11 **program received a reduction from \$24,999.99 to \$18,476.00 to the FY2009 TB State**
12 **contract which basically supports, in part, one position and ends June 30, 2009; and**

13 **WHEREAS, the TB State budget is adjusted by a decrease of \$4,135.42 in salaries, \$1,323.33 in**
14 **Fringe Benefits, and \$7.52 in Supplies – Office, with a corresponding decrease of**
15 **\$1,057.72 in Indirect Cost Charges; and**

16 **WHEREAS, the attached budget amendment now reflects a total decrease of \$6,523.99, which**
17 **includes an indirect cost decrease of \$1,057.72, from a total budget amount of**
18 **\$24,999.99 for a new budget total of \$18,476.00.**

19 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby:**

- 20 **1. Accepts and approves the Division of Community Health Service, Tuberculosis**
21 **Control Services Program – State Budget Amendment #1, reducing the current**
22 **budget by a total amount of \$6,523.99, from \$24,999.99, to a new revised total**
23 **budget amount of \$18,476.00.**
- 24 **2. Authorizes the Nation to incur expenditures upon approval of this resolution from**
25 **July 1, 2008 through June 30, 2009.**

26 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
27 **Nation officials, to wit: the Chairman and Vice Chairman and any designated official**
28 **are authorized to administer and expend these funds, provided however, that any**
29 **amendment affecting the funds or funding levels of the contract shall be submitted**
30 **for further prior approval by the Tohono O'odham Legislative Council.**


