

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2009 Department of Health & Human Services, Division of Community Health Tuberculosis Control Services Program – Tribal Budget Amendment #1)

RESOLUTION NO. 09-405

1 **WHEREAS, the Tohono O'odham Nation has operated the Tuberculosis Control Services Program**
2 **to help prevent the spread of the disease through community education, prevention,**
3 **early detection, comprehensive regimens and careful follow-up with individuals; and**

4 **WHEREAS, the Division of Community Health, Tuberculosis Control Services Program desires to**
5 **continue the services it provides to TB susceptible and diagnosed patients; and**

6 **WHEREAS, funding for the operation of the Tohono O'odham Tuberculosis Control Services**
7 **Program has been provided in part through State and Tribal supplemental funding;**
8 **and**

9 **WHEREAS, the Tohono O'odham Nation, Division of Community Health Services through Grants**
10 **& Contracts received notification from the TB Program Manager, ADHS, that the**
11 **program received a reduction in funding to the FY2009 TB State contract which**
12 **basically supports, in part, one position and ends June 30, 2009; and**

13 **WHEREAS, the TB State funding reduction, therefore, requires adjustments as increases in**
14 **Salary, and Fringe, \$2,430.90, and Supplies – Office, \$385.36, for a total increase of**
15 **\$2,816.26 to the TB Tribal budget; and**

16 **WHEREAS, to cover the increase cost, the TB Tribal budget is also adjusted with reductions in the**
17 **Tuition and Registration, Travel Expense and Uniforms operational line items for a**
18 **total decrease of \$2,816.26, which is off-set by the total increase for the same amount,**
19 **with no change to the total budget amount.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby:**

- 21 **1. Approves the Division of Community Health, Tuberculosis Control Services**
22 **Program – Tribal Budget Amendment #1, making a total \$2,816.26, off-setting**
23 **adjustment to cover TB-State reduction affecting Salary, Fringe, and Supplies –**
24 **Office, with no change to the total budget amount of \$41,597.70**
- 25 **2. Authorizes the Nation to incur expenditures upon approval of this resolution from**
26 **October 1, 2008 through September 30, 2009.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 9TH. Day**
28 **of JULY, 2009 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0- AGAINST;**
29 **01 NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Section 1 (d)(2)**
30 **(3) and (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
31 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
32 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
