

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of the FY 2009 Tohono O'odham Department of Health and Human Services,
Division of Community Health Service, DHHS, AFC, Family Violence Prevention and
Services Grant Budget Amendment No. 1)

RESOLUTION NO. 09-406

1 **WHEREAS, prevention of injuries is a priority for the Tohono O'odham Nation; and**

2 **WHEREAS, family violence is a source of injuries from and among individuals and family**
3 **members; and**

4 **WHEREAS, the Domestic Violence Program and the "Circles of Strength" Domestic Violence**
5 **Coalition are working to raise awareness of family violence and continue the**
6 **development of services for victims and their families; and**

7 **WHEREAS, the FY 2009 Family Violence Prevention and Services grant budget was prepared,**
8 **according to tribal policy and procedure in the spring, prior to notification of funding**
9 **allocation, for a projected total amount of \$138,371.00; and**

10 **WHEREAS, the September 02, 2008, funding notice identified an allotment at \$139,339 with a**
11 **decrease of (6,141), the actual allowance being \$133,198.00; and**

12 **WHEREAS, savings were realized in the Salaries and Fringe Benefits line items due to a three**
13 **month vacancy (Family Resource Specialist position), for a total savings of \$5,470.50;**
14 **and**

15 **WHEREAS, the savings of \$5,470.50 cancels the funding allotment decrease of \$5,173.00 from the**
16 **current budget of \$138,371.00 and results in a net savings of \$297.50; and**

17 **WHEREAS, additional program needs require redistribution among operational line items**
18 **including decreases in Tuition and Registration, Professional Services, and Public**
19 **Relations, for a total decrease amount of \$7,282.95, and increases in Travel Expense,**
20 **Supplies - Office, Program Supplies, Food, and Client Support for a total re-program**
21 **amount of \$7,572.60; and**

22 **WHEREAS, the total revised budget result in a direct cost reimbursement amount of \$112,062.46,**
23 **the indirect cost charges are also adjusted at \$21,135.54, and the new revised budget**
24 **total amount is \$133,198.00.**

25 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby:**

- 26 **1. Approves the revised FY 2009 Family Violence Prevention and Services Grant**
27 **Budget total of \$133,198.00, which is a net decrease of \$5,173.00 from the previous**
28 **\$138,371.00.**

BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham Nation's officials, to wit: the Chairman and Vice Chairman and any designated official are authorized to administer and expend these funds, provided however, that any amendment affecting the funds or funding levels of the grant shall be submitted for further prior approval by the Tohono O'odham Legislative Council.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 9TH. Day of JULY, 2009 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0- AGAINST; 01 NOT VOTING; and 02 ABSENT, pursuant to the powers vested in the Council by Section 1(9) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).




