1 **WHEREAS, KOHN management has prepared and presented the attached amendment # 2 of its**
2 **FY 2009 budget, incorporated into this resolution by this reference, to provide for**
3 **additional operational expenses and the purchase of a replacement vehicle; and**

4 **WHEREAS, the amendment allocates \$34,400.00 towards the purchase of a replacement vehicle,**
5 **creating a new line item, 750 – Major Capital Equipment; and**

6 **WHEREAS, KOHN management has presented the attached amendment # 2 of its FY 2009 budget**
7 **to the Executive Office and appropriate oversight committees.**


8 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**
9 **approves and authorizes amendment # 2 of KOHN 91.9 FM's FY 2009 budget to be**
10 **expended as attached.**

11 **BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that it approves the**
12 **creation a new line item, 750 – Major Capital Equipment in the KOHN 91.9 FM FY 2009**
13 **budget.**

14 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
15 **Nation's Officials to-wit: the Chairman, and any designated official, are authorized to**
16 **execute the budget amendment, provided however, that any amendments affecting**
17 **the funds or funding levels of the budget shall be submitted for further prior approval**
18 **by the Tohono O'odham Legislative Council.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09TH. Day**
20 **of JULY, 2009 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0- AGAINST;**
21 **-0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Article VI**
22 **Section 1 (d)(3) of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
23 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
24 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
25 **Stat. 984).**


