**RESOLUTION NO. 09-408**

1 **WHEREAS, by Resolution No. 08-314, the Tohono O'odham Legislative Council (Council) approved**  
2 **and authorized the KOHN 91.9 FM's Corporation for Public Broadcasting (CPB)**  
3 **Community Service Grant (CSG) for fiscal year 2009; and**

4 **WHEREAS, KOHN has prepared the attached budget amendment three (3), incorporated into this**  
5 **resolution by this reference, to re-allocate funds, in the amount of \$ 36,600.00 into a**  
6 **new line item 721 - Supplies Other, to provide for Primary Control Room upgrade and**  
7 **additional production equipment; and**

8 **WHEREAS, KOHN management has presented the attached amendment three of its FY 2009 CPB**  
9 **CSG grant to the Executive Office and appropriate oversight committees.**


10 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**  
11 **approves and authorizes amendment # 3 of KOHN 91.9 FM's CPB CSG FY 2009 budget**  
12 **to be expended as attached.**

13 **BE IT FURTHER RESOLVED that it approves a new line item 721 - Supplies Other.**

14 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
15 **Nation's Officials to-wit: the Chairman, and any designated official, are authorized to**  
16 **execute the grant, provided however, that any amendments affecting the funds or**  
17 **funding levels of the grant shall be submitted for further prior approval by the Tohono**  
18 **O'odham Legislative Council.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09<sup>TH</sup>. Day**  
20 **of JULY, 2009 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0- AGAINST;**  
21 **-0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Article VI**  
22 **Section 1 (d)(2) & (3) of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
23 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
24 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
25 **Stat. 984).**
