RESOLUTION NO. 09-415

1 WHEREAS, on July 08, 2009 the Tohono O'odham Legislative Council approved the method of  
2 distribution of the Fourth Per Capita Distribution pursuant to Legislative Council  
3 Resolution No. 09-398; and

4 WHEREAS, the anticipated expenses for the Fourth Per Capita Distribution are reflected in the  
5 proposed FY2009 Fourth Per Capita Operating Budget; and


6 WHEREAS, the Chairman's Office and Budget & Finance have reviewed and approved the attached  
7 budget in the amount of \$81,488.35 for all anticipated expenses related to the Fourth  
8 Per Capita Distribution.

9 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves  
10 and authorizes the attached budget - titled Fourth Per Capita Operating Budget in the  
11 amount of \$81,488.35 and authorizes an appropriation from the Desert Diamond  
12 Savings Account to fund the Fourth FY2009 Per Capita Operating Budget.


13 BE IT FINALLY RESOLVED that any unexpended balance from the Fourth Per Capita Operating  
14 Budget is to be returned to the Desert Diamond Saving Account.

15 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10<sup>TH</sup> Day  
16 of JULY, 2009 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0- AGAINST;  
17 -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Article VI  
18 Section 1 (d)(2) of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono  
19 O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -  
20 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48  
21 Stat. 984).
