

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving Budget Amendment No. 2 to FY 2009 Office of the Treasurer Budget**  
**Account # 01-1048)**

RESOLUTION NO. 09-416

1 **WHEREAS, the Tohono O'odham Legislative Council approved the FY2009 Office of the Treasurer**  
2 **Budget Account No. 01-1048 pursuant to Legislative Council Resolutions No.08-265 and**  
3 **08-547; and**

4 **WHEREAS, the Office of the Treasurer submits for review and approval FY 2009 Budget**  
5 **Amendment Number 2 for Budget Account No. 01-1048; and**

6 **WHEREAS, the budget is amended to increase line items 720 Office Supplies by \$10,000.00 and 721**  
7 **Supplies Other by \$29,638.60 and add line items 722 Program Supplies for \$5,000.00**  
8 **and 850 Food for \$2,000.00 and decrease line item 750 Major Capital in the amount of**  
9 **\$46,638.60 to purchase necessary office supplies and other administrative costs**  
10 **related to the issuance of per capita checks and other operational cost for the Office**  
11 **of the Treasury; and**

12 **WHEREAS, the FY 2009 Office of the Treasurer Budget Amendment Number 2 for Account No. 01-**  
13 **1048 has been presented to the Budget and Finance Committee.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**  
15 **the Office of the Treasurer Budget Amendment Number 2 to increase line items 720**  
16 **Office Supplies by \$10,000.00 and 721 Supplies Other by \$29,638.60 and add new line**  
17 **items 722 Program Supplies for \$5,000.00 and 850 Food for \$2,000.00 and decrease line**  
18 **item 750 Major Capital in the amount of \$46,638.60 to purchase necessary office**  
19 **supplies and other administrative costs related to the issuance of per capita checks**  
20 **and other operational cost for the Office of the Treasury.**

21 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
22 **Official, to wit; the Chairman, Vice-Chairman and any designated official are**  
23 **authorized to administer the FY2009 Office of the Treasurer Budget, provided**  
24 **however, that any amendments affecting the funds or funding levels of the budget**  
25 **shall be submitted for further prior approval by the Tohono O'odham Legislative**  
26 **Council.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10<sup>TH</sup>. Day**  
28 **of JULY, 2009 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0- AGAINST;**  
29 **-0- NOT VOTING; and -0- ABSENT, pursuant to the powers vested in the Council by Article VI**  
30 **Section 1 (d)(2) of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
31 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
32 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
33 **Stat. 984).**
