

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of FY 2009 Adult Care Services Program Budget Amendment #1
Account: 10-1304)

RESOLUTION NO. 09-418

1 **WHEREAS, the Tohono O'odham Nation has historically contracted certain functions from the**
2 **Bureau of Indian Affairs; and**

3 **WHEREAS, the Adult Care Services fiscal year 2009 budget amendment 1 has been prepared to**
4 ***decrease* the funds that were budgeted for Tuition and Registration; Travel Expense;**
5 **Utilities; Office Supplies; Other Supplies; Equipment Repair and Maintenance; Vehicle**
6 **Repair and Maintenance; and Public Relation line items; and**

7 **WHEREAS, the funds from the decreased line items will be utilized in the Mileage-GSA;**
8 **Communication Expense and Lease/Rentals line items; and**

9 **WHEREAS, the Indirect Cost amount increased from \$23,105.81 to \$23,202.56 (increase of \$96.75)**
10 **due to funds transferred from the Public Relations 812 *without* Indirect Cost and into**
11 **other line items *with* Indirect Costs; and**

12 **WHEREAS, the bottom line total of the Adult Care Program budget also increased from**
13 **\$143,015.67 to \$143,112.42 due to the increase in the Indirect Cost line item.**

14 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative that it hereby approves:**

- 15 **1. The Adult Care Services fiscal year 2009 budget amendment 1 that has been**
16 **prepared to *decrease* the funds for Tuition and Registration; Travel Expense;**
17 **Utilities; Office Supplies; Other Supplies; Equipment Repair and Maintenance;**
18 **Vehicle Repair and Maintenance; and Public Relation line items.**
- 19 **2. The funds from the decreased line items to be utilized in the Mileage-GSA;**
20 **Communication Expense and Lease/Rentals line items.**
- 21 **3. The Indirect Cost amount increase from \$23,105.81 to \$23,202.56 (increase of**
22 **\$96.75) due to funds transferred from the Public Relations 812 *without* Indirect**
23 **Cost and into other line items *with* Indirect Costs.**
- 24 **4. The bottom line total of the Adult Care Program budget increase from \$143,015.67**
25 **to \$143,112.42 due to the increase in the Indirect Cost line item.**

26 **BE IT FINALLY RESOLVED that the Tohono O'odham Nation officials, to wit: The Chairman is hereby**
27 **authorized to negotiate and execute the grant, provided however, that any**
28 **amendments affecting the funding or funding levels of this contract shall be**
29 **submitted for further prior approval by this Council.**
