RESOLUTION NO. 09-421

1 **WHEREAS, Resolution No. SODC 09-162, "Approving the FY 2009 Sif-Oidak District Administration**
2 **Budget Amendment #1", was enacted by the Sif-Oidak District Council, at a regular**
3 **meeting held on June 27, 2009; and**

4 **WHEREAS, the FY 2009 Sif-Oidak District Administration Budget Amendment #1, is amending the**
5 **justification to line items (610) Salaries and (750) Major Capital; and**

6 **WHEREAS, the Tohono O'Odham Legislative Council Budget & Finance Committee reviewed the**
7 **FY 2009 Sif-Oidak District Administration Budget Amendment #1 on July 09, 2009 and**
8 **recommends approval.**

9 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative Council hereby**
10 **approves the FY 2009 Sif-Oidak District Administration Budget Amendment #1,**
11 **amending the justifications to include the following:**


12 **610 Salaries: emergency hires and seasonal laborers @ \$8.00/hr. x approximately**
13 **950 x 5 = \$37,128.00 and zeroing out the Planner part-time position which has**
14 **been vacant.**

15 **750 Major Equipment: the purchase of a Van.**

16 **BE IT FINALLY RESOLVED that any amendments affecting the funding or funding levels of the**
17 **attached budget shall be submitted for further prior approval by the Tohono O'Odham**
18 **Legislative Council.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10TH. Day**
20 **of JULY, 2009 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0- AGAINST;**
21 **-0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Article VI**
22 **Section 1 (d)(2) & (3) of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
23 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
24 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
25 **Stat. 984).**


