

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approves the DHHS, Division of Community Health Service, Community
Counseling and Relations Service FY 2009 Budget Amendment #1)

RESOLUTION NO. 09-422

1 **WHEREAS, the Tohono O'odham Nation has historically contracted certain functions from the**
2 **Indian Health Service; and**

3 **WHEREAS, the Community Counseling and Relations Service provides screening, outreach and**
4 **education for the full spectrum of sexually transmitted disease (STD), including**
5 **HIV/AIDS, syphilis, and viral Hepatitis C; and**

6 **WHEREAS, non-recurring (one time) funds in the amount of \$49,127.00 was received in**
7 **Modification No. 33 to the Master P.L. 93-638 Contract HHS1249200400001C, to support**
8 **and enhance the Nation's capacity to positively impact the STD/HIV/AIDS Hepatitis C**
9 **disease burden; and**

10 **WHEREAS, a program increase in the amount of \$2,147.00 was received in Modification No. 37 to**
11 **the Master P.L. 93-638 Contract HHS1249200400001C; and**

12 **WHEREAS, the Community Counseling and Relations Service (CCRS) FY 2009 total combined base**
13 **and savings budget of \$185,903.27 was approved in Resolution No. 08-271; and**

14 **WHEREAS, the program increases noted above provide a sum of \$51,274.00, and a revised total**
15 **budget of \$237,177.27.**

16 **NOW, THEREFORE, BE IT RESOLVED THAT the Tohono O'odham Legislative Council hereby:**

- 17 **1. Accepts and approves the attached program budget increases of \$2,147.00 and**
18 **the one-time \$49,127.00 for an FY 2009 overall program increase of \$51,274.00,**
19 **and a revised total budget of \$237,177.27, and**
- 20 **2. Authorizes the Nation to incur expenditures upon approval of this resolution**
21 **from October 1, 2008 through September 30, 2009**

22 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
23 **Nation officials, to wit: the Chairman and Vice Chairman and any designated official**
24 **are hereby authorized to obligate and expend contract funds, provided however, that**
25 **any amendments affecting the funds or funding levels shall be submitted for further**
26 **prior approval by the Tohono O'odham Legislative Council.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10TH. Day**
28 **of JULY, 2009 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0- AGAINST;**
29 **-0- NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council by Article VI**
30 **Section 1 (d)(2)(3) & (f) of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
31 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
32 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
33 **Stat. 984).**
