

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approval of the One Stop Division Bureau of Indian Affairs-477 Budget FY 2009 DOL**  
**Supplemental Youth Services Budget)**

RESOLUTION NO. 09-427

1 WHEREAS, the One Stop Division Bureau of Indian Affairs-477 Budget FY 2009 budget  
2 administers (WIA) P.L. 102-477 programs under the Education Department One Stop  
3 Division from February 17, 2009 to June 30, 2011 in the combined amount of  
4 \$288,020.00; and

5 WHEREAS, the One Stop Division Bureau of Indian Affairs-477 Budget FY 2009 budget has been  
6 developed as part of the DOL Supplemental Youth Services for Native Americans 2009  
7 Recovery Act; and

8 WHEREAS, this budget for Supplemental Youth Services in the amount of \$288,020.00 requires  
9 a new account number to avoid comingling of funds per Training and Employment  
10 Guidance Letter (TEGL) No. 17-08; and

11 WHEREAS, the DOL Supplemental Youth Services Budget was reviewed by the Human Resources  
12 Development Committee and the Budget & Finance Committee.

13 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby  
14 accept, approve, and authorize the expenditure of the DOL Supplemental Youth  
15 Services Budget, Education Department-One Stop Division Bureau of Indian Affairs  
16 -477 Budget FY 2009 of \$288,020.00, FY 09 beginning February 17, 2009 to September  
17 30, 2010.

18 BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham  
19 Nation's Officials, to wit; the Chairman and any official appointed designee is hereby  
20 authorized to expend the budget provided however, that any amendment affecting  
21 the funding or funding levels of this budget shall be submitted for further prior  
22 approval by this Council.

23 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 16<sup>TH</sup>. Day  
24 of JULY, 2009 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0- AGAINST;  
25 -0- NOT VOTING; and [0] ABSENT, pursuant to the powers vested in the Council by Article VI Section  
26 1 (d)(2)(3) & (f) of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham  
27 Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs  
28 (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
