

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Master List for the Fourth Per Capita Distribution for Eligible Tohono
O'odham Minor Members)

RESOLUTION NO. 09-429

1 WHEREAS, on June 28th, 1997 the Nation's voters approved Initiative No. IN-01-97, the "Tohono
2 O'odham Voice in the Use of Gaming Revenues" ("Initiative"), which authorizes per
3 capita payments to the Nation's members provided that sufficient gaming revenues
4 are available; and

5 WHEREAS, the Ordinance for the Regulation of Gaming Activities within the Tohono O'odham
6 Nation ("Gaming Ordinance") was subsequently amended to authorize per capita
7 distribution payments in accordance with the Initiative (Resolution No. 97-303); and

8 WHEREAS, the Legislative Council did adopt the Per Capita Revenue Allocation Plan for a Fourth
9 per capita distribution per Legislative Council Resolution No.09-164; and

10 WHEREAS, the Chairman of the Nation did receive written notification from the Department of
11 the Interior on June 15, 2009 that the Nation's Revenue Allocation Plan had been
12 approved; and


13 WHEREAS, Tohono O'odham Nation Department of Membership Services submits to the Tohono
14 O'odham Legislative Council the Master List for Eligible Tohono O'odham Minor
15 Members for review and approval for the Fourth Per Capita Distribution; and

16 WHEREAS, the total eligible Tohono O'odham Minor Members for the Fourth Per Capita
17 Distribution is 8,665.

18 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the
19 Master List for Eligible Minor Tohono O'odham Members for the Fourth Per Capita
20 Distribution as presented by the Tohono O'odham Nation Department of Membership
21 Services for a total 8,665 Minor Eligible Members.

22 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 16TH. Day
23 of JULY, 2009 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0- AGAINST;
24 -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Article VI
25 Section 1 (d)(2) of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono
26 O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -
27 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
28 Stat. 984).
