

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Norquay Construction Contract for HOPP Building Renovation)**

RESOLUTION NO. 09-432

1 WHEREAS, the Department of Health and Human Services of the Tohono O'odham Nation (the
2 "Department") has plans to perform major renovation at the Healthy O'odham
3 Promotion Program ("HOPP") building at the health complex in Sells; and

4 WHEREAS, the Department has selected Norquay Construction, Inc., as the construction
5 contractor for this work, and has negotiated a construction contract, a copy of which
6 is attached hereto; and


7 WHEREAS, the Legislative Council has approved a limited waiver of Sovereign Immunity for this
8 Construction Contract in Resolution No. 09-367; and

9 WHEREAS, the Contracting and Procurement Authority, Chapter 1, Article 4, § 1402(F) of the
10 Finance Code requires approval of the Legislative Council of construction contracts
11 with a total value in excess of \$500,000.


12 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative Council hereby
13 approves the Norquay Construction Contract in the amount of \$587,400.97 and
14 authorizes the Chairman or his designee to execute and administer the Contract.

15 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 16TH Day
16 of JULY, 2009 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0- AGAINST;
17 -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Article VI
18 Section 1 (f) of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham
19 Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs
20 (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).


