

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Setting August 19, 2009 Special Session to Address District Audit Updates)**

**LEGISLATIVE ORDER NO. 09-439**

1 **WHEREAS, the Legislative Council is vested with the power "to establish rules and procedures**  
2 **to regulate all meetings of the Tohono O'odham Council, standing committees,**  
3 **boards and special committees." (Constitution of the Tohono O'odham Nation,**  
4 **Article VI, Section 1(a)); and**

5 **WHEREAS, the Legislative Rules of the Tohono O'odham Legislative Council vests the Council**  
6 **with the authority to "by majority vote, call for a special session" (Legislative Rules**  
7 **of the Tohono O'odham Legislative Council, Article I, Section 1.D.1.); and**

8 **WHEREAS, the Legislative Council Budget and Finance Committee has requested a special**  
9 **session on August 19, 2009 at 9:00 a.m. to address District Audit Updates.**

10 **NOW, THEREFORE, BE IT ORDERED that the Tohono O'odham Legislative Council hereby sets a**  
11 **special session on August 19, 2009 at 9:00 a.m. to address District Audit Updates.**

12 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 03<sup>RD</sup>. Day of**  
13 **AUGUST, 2009 at a meeting at which a quorum was present with a vote of 2,503.25 FOR; 92.25**  
14 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**  
15 **Article VI, Section 1 (a) of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
16 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
17 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
18 **Stat. 984).**
