

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Appointing Representative Cynthia Manuel to the NCAI Workgroup on Reporting,**  
**Accountability and Auditing and Appointing Representative Frances Miguel as**  
**the Nation's Alternate)**

RESOLUTION NO. 09-440

1 **WHEREAS, the National Congress of American Indians ("NCAI") has formed several national**  
2 **workgroups consisting of tribal leaders to advise and work with the Bureau of Indian**  
3 **Affairs ("BIA") on issues affecting Indians nationwide; and**

4 **WHEREAS, the NCAI encourages tribal leaders to continue their strong participation and to have**  
5 **a voice on important national issues and the Tohono O'odham Nation wishes to do the**  
6 **same; and**

7 **WHEREAS, the NCAI has established a national workgroup on Reporting, Accountability and**  
8 **Auditing to advise the BIA on how to develop a consistent reporting format in order to**  
9 **more readily identify unmet needs, justify increased appropriations to tribes, and**  
10 **provide accountability to the United States Congress on the use of such funds; and**

11 **WHEREAS, the Legislative Council had previously appointed Representative Gerald Fayuant to the**  
12 **national workgroup representing the Tohono O'odham Nation (Resolution No. 07-531)**  
13 **and appointed Representative Cynthia Manuel as his alternate; and**

14 **WHEREAS, it is necessary to appoint NCAI Reporting, Accountability and Auditing Workgroup**  
15 **representatives following the June 8, 2009 election of Legislative Council standing**  
16 **committees, including the members of the Budget and Finance Committee.**

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby appoints**  
18 **Representative Cynthia Manuel as the Tohono O'odham Nation's representative on the**  
19 **NCAI Reporting, Accountability and Auditing Workgroup, and appoints Representative**  
20 **Frances Miguel as Representative Manuel's alternate; provided that an appointment**  
21 **made pursuant to this resolution (1) shall supercede any prior NCAI Reporting,**  
22 **Accountability and Auditing Workgroup appointments and (2) shall expire if the**  
23 **appointee is no longer serving on the Legislative Budget and Finance Committee for**  
24 **any reason.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 03<sup>RD</sup>. Day**  
26 **of AUGUST, 2009 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0-**  
27 **AGAINST; 01 NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**  
28 **Section 1 (d)(f) & (j) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
29 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
30 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
31 **18, 1934 (48 Stat. 984).**
