

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approval of the Public Health Emergency Response – Early Warning Infectious**  
**Disease Surveillance (EWIDS), FY 2009 Budget)**

**RESOLUTION NO. 09-443**

1 **WHEREAS, the Tohono O'odham Nation is concerned with the health, welfare and safety of its**  
2 **members who reside on or near the Tohono O'odham Nation Reservation, including**  
3 **the O'odham in Mexico; and**

4 **WHEREAS, Public Health Preparedness and Response for Bioterrorism is within the charter of the**  
5 **Tohono O'odham Department of Health and Human Services, Division of Community**  
6 **Health Service, and**

7 **WHEREAS, the Tohono O'odham Nation entered into an Intergovernmental Agreement (IGA) with**  
8 **the Arizona Department of Health Services (ADHS) for (Public Health) Preparedness**  
9 **and Response for Bio Terrorism on August 31, 2003; and**

10 **WHEREAS, the Tohono O'odham Nation in Resolution No. 04-265 approved the IGA; and**

11 **WHEREAS, by Resolution No. 05-230, the IGA budget Amendment No. 1 was approved, and**  
12 **included the provision to extend the IGA to August 30, 2008, and expanded the Scope**  
13 **of Work to provide for Surveillance and Epidemiology focus areas; and**

14 **WHEREAS, the Price Sheet for Amendment No. 1 included funding for Early Warning Infection**  
15 **Disease Surveillance (EWIDS); and**

16 **WHEREAS, ADHS fiscal Year 2009 EWIDS funding notice was received, and budget prepared in the**  
17 **amount of 40,000.00; and**

18 **WHEREAS, by Resolution No. 09-123, a new IGA for the period, August 9, 2008 through August 8,**  
19 **2013 was approved by the Tohono O'odham Legislative Council.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby:**

- 21 **1. Approves the Early Warning Infectious Disease Surveillance (EWIDS) budget in the**  
22 **amount of \$40,000.00.**
- 23 **2. Authorizes the Nation to obligate and expend funds, upon approval of this**  
24 **resolution, through August 8, 2009.**

25 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
26 **Nation officials, to wit: the Chairman and Vice-Chairman and any designated official**  
27 **are hereby authorized to negotiate annual Contract Period performance terms and**  
28 **its associated budget, provided however, that any amendment affecting the funds or**  
29 **funding levels of the contract shall be submitted for further prior approval by the**  
30 **Tohono O'odham Legislative Council.**
