

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2010 Title XX Budget)

RESOLUTION NO. 09-444

1 **WHEREAS, the Tohono O'odham Nation provides services to improve the availability,**
2 **affordability and quality of child care through funding provided by the Arizona**
3 **Department of Economic Security's (A.D.E.S.) Planned Social Services Block Grant**
4 **(S.S.B.G.) Title XX Program; and**

5 **WHEREAS, the Tohono O'odham Nation has consistently supported the nurturance of its young**
6 **members by providing for their welfare through various programs and services**
7 **designed to meet their special needs; and**

8 **WHEREAS, the Tohono O'odham Nation's Division of Early Childhood Development is submitting**
9 **for review and approval the FY 2010 Title XX Budget in the amount of \$120,644.00.**

10 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
11 **approve and authorize the Division of Early Childhood Development to incur**
12 **expenditure from July 1, 2009 to June 30, 2010 under the FY 2010 A.D.E.S./S.S.B.G. Title**
13 **XX Block Grant Program Budget in the amount of \$120,644.00 as attached hereto.**

14 **1. Title XX Block Grant Program - \$120,644.00.**

15 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
16 **Nation's Official, to wit: the Chairperson and any designated official are authorized to**
17 **negotiate and expend the budget, provided however, that any amendments affecting**
18 **the funds or funding levels of the budget shall be submitted for further prior approval.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 04TH. Day**
20 **of AUGUST, 2009 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0-**
21 **AGAINST; -0- NOT VOTING; and [06]ABSENT, pursuant to the powers vested in the Council by Section**
22 **1 (d)(2)(3)&(f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
23 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
24 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
25 **18, 1934 (48 Stat. 984).**




