

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Holding August 7, 2009 Legislative Council Session at Tohono O'odham Farming Authority Operations)**

**LEGISLATIVE ORDER NO. 09-445**

1 **WHEREAS, the Legislative Council is vested with the power "to establish rules and procedures to**  
2 **regulate all meetings of the Tohono O'odham Council, standing committees, boards**  
3 **and special committees." (Constitution of the Tohono O'odham Nation, Article VI,**  
4 **Section 1(a)); and**


5 **WHEREAS, Article I, Section 2.C. of the Legislative Rules of the Tohono O'odham Legislative**  
6 **Council, as amended, provides that "[a]ll Legislative Council sessions shall be held at**  
7 **the Tohono O'odham Legislative Council chambers located in Sells, Tohono O'odham**  
8 **Nation, with the following exceptions. . . . [a] majority of all the legislative**  
9 **representatives may vote to hold a session in some location other than the chambers**  
10 **located at Sells."; and**

11 **WHEREAS, the Legislative Agricultural Committee has recommended that the Legislative Council**  
12 **receive an update of the Tohono O'odham Farming Authority operations and tour the**  
13 **San Lucy and Vaiva Vo Farms during the August 7, 2009 general session.**

14 **NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that**  
15 **roll call for the August 7, 2009 general session shall be conducted at San Lucy Farms**  
16 **at 9:00 a.m., followed by an update of the Tohono O'odham Farming Authority**  
17 **operations and a tour of San Lucy and Vaiva Vo Farms.**

18 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 04<sup>TH</sup> Day of**  
19 **AUGUST, 2009 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0- AGAINST;**  
20 **-0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Section 1 (a) of**  
21 **Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**  
22 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**  
23 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
