

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the No Cost Grant Extension and Amendment #1 for the DPS Arrest Program
Grant No. 2006-WE-AX-0006 from July 01, 2009 through December 31, 2009)

RESOLUTION NO. 09-452

1 **WHEREAS, the Tohono O'odham Nation Police Department has successfully received an award**
2 **administered by the Office of Justice Programs (OJP) and Office on Violence Against**
3 **Women (OVW) from the Grants to Encourage Arrest and Enforcement of Protection**
4 **Orders Program funded through the US Department of Justice (DOJ) for the amount**
5 **of \$353,063.00 under grant number 2006-WE-AX-0006; and**

6 **WHEREAS, the grant amount is funding for a two year period beginning October 01, 2006 through**
7 **September 30, 2008; and**

8 **WHEREAS, the TONPD has received and approved a no cost grant extension from July 01, 2008**
9 **through June 30, 2009 and now, a second extension from July 01, 2009 to December 31,**
10 **2009; and**

11 **WHEREAS, with this no cost grant extension the salary line item has been adjusted to cover the**
12 **remaining months of July 01 through September 30, 2009 for the positions under this**
13 **grant; and**

14 **WHEREAS, the salaries and fringe have been adjusted for October 01, 2009 through December 31,**
15 **2009.**

16 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**
17 **approves budget amendment no 1. and authorizes the no cost grant extension for the**
18 **Office of Justice Program Office on Violence Against Women Grant No. 2006-WE-AX-**
19 **0006 from July 01, 2009 through December 31, 2009.**

20 **BE IT FURTHER RESOLVED that the salary line items 610 and 620 have been amended to cover the**
21 **remaining months from July 01, 2009 through September 30, 2009.**

22 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that it hereby authorizes the**
23 **Chairperson and any designated official to expend and administer the budget as**
24 **attached, provided that any amendments affecting the funds or funding level shall be**
25 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06TH. Day**
27 **of AUGUST, 2009 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0-**
28 **AGAINST; -0- NOT VOTING; and [02]ABSENT, pursuant to the powers vested in the Council by Section**
29 **1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
30 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
31 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
32 **Stat. 984).**
