**RESOLUTION NO. 09-458**

1 **WHEREAS, the Tohono O'odham Legislative Council is empowered to approve, amend, and modify**  
2 **budgets that have been prior approved; and**

3 **WHEREAS, Resolution No. 08-573 approves the San Lucy District FY 2009 Budget authorizing San**  
4 **Lucy District to expend funds in the amount of \$2,690,556.18; and**

5 **WHEREAS, San Lucy District Resolution No. SI 05-52-09 approves to reallocate funds from within**  
6 **the existing budgets for the San Lucy District Council, Elderly Program, Health**  
7 **Program, Human Service and Administration, and that funds totally \$29,225.86 from**  
8 **the Administration Budget will be distributed in the amount of \$18,625.86 to the**  
9 **District Council's Budget; \$2,000.00 to the Health Program; \$8,600.00 to the Human**  
10 **Service program to cover over-expenditures and anticipated cost to end of the fiscal**  
11 **year; and**

12 **WHEREAS, the Budget and Finance Committee has reviewed the budget modifications/**  
13 **amendments and reallocation of funds from within the San Lucy District FY 2009**  
14 **Budget.**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**  
16 **approves the attached San Lucy District FY 2009 budget modifications/amendment**  
17 **and reallocation of funds for San Lucy District Council Budget Modification/**  
18 **Amendment #2; Administration Budget Modification/Amendment #1; Elderly Program**  
19 **Budget Modification/Amendment #2; Health Program Budget Modification/**  
20 **Amendment #1; Human Service Budget Modification/ Amendment #1.**

21 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 19<sup>TH</sup>. Day**  
22 **of AUGUST, 2009 at a meeting at which a quorum was present with a vote of 2,389.2 FOR; -0-**  
23 **AGAINST; -0- NOT VOTING; and 206.3 [05] ABSENT, pursuant to the powers vested in the Council by**  
24 **Section 1 (d)(2)&(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
25 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
26 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
27 **18, 1934 (48 Stat. 984).**
