

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending Resolution No. 08-573)

RESOLUTION NO. 09-459

1 **WHEREAS, the Tohono O'odham Legislative Council passed Resolution No. 08-573 "Approving the**
2 **San Lucy District FY 2009 Budget" thereby authorizing San Lucy District to conduct**
3 **district operations and to expend funds in the amount of \$2,690,556.18; and**

4 **WHEREAS, San Lucy District Resolution No. SL 07-87-09 "Approving San Lucy District FY 2009**
5 **Budget Amendment No.1" addresses compensation increases for San Lucy District**
6 **staff subsequent to approval of the FY 2009 District Budget; and**

7 **WHEREAS, San Lucy District is proposing to use unobligated funds from Gaming Revenues**
8 **amounting to \$5,747.22 and Mining Royalties in the amount of \$8,898.07, plus**
9 **reallocating \$724.79 from within the San Lucy District Administration budget line item**
10 **to 760 to line item 620 for a total of \$15,370.08; and**


11 **WHEREAS, the Budget and Finance Committees have reviewed the district' budget amendment**
12 **and is forwarding it to the Tohono O'odham Nation - Tribal Council for their**
13 **consideration.**

14 **NOW, THEREFORE, BE IT RESOLVED the Tohono O'odham Legislative Council approves the**
15 **attached San Lucy District Budget Amendment No. 1 increasing the FY 2009 Budget by**
16 **\$14,645.29, wherein the approved budget is increased from \$2,690,556.18 to**
17 **\$2,705,201.47 is hereby approved.**

18 **BE IT FINALLY RESOLVED that Gaming Revenue in the amount of \$5,747.22; Mining Royalties in the**
19 **amount of \$8,898.07 and reallocation of \$724.79 from the San Lucy District**
20 **Administration Budget line item 760 to line item 620 shall fund the increase.**

21 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 19TH. Day**
22 **of AUGUST, 2009 at a meeting at which a quorum was present with a vote of 2,389.2 FOR; -0-**
23 **AGAINST; -0- NOT VOTING; and 206.3 [05]ABSENT, pursuant to the powers vested in the Council by**
24 **Section 1 (d)(2)&(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
25 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
26 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
27 **18, 1934 (48 Stat. 984).**


