

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approval of the FY 2009 Tohono O'odham Department of Health and Human Services,**  
**Division of Community Health, Motor Vehicle Injury Prevention STOP Project**  
**Budget Amendment No. 1 – Acct. No. 11-1478)**

**RESOLUTION NO. 09-463**

1 **WHEREAS, the Tohono O'odham Department of Health and Human Services has received a four**  
2 **year cooperative agreement from the Department of Health and Human Services,**  
3 **Center for Disease Control National Center for Injury Prevention and Control, also**  
4 **known as Securing Tohono O'odham People (STOP) project for the project period of**  
5 **September 01, 2004 through August 31, 2008; and**

6 **WHEREAS, the funding agency has approved an additional year by extending year four project**  
7 **period through August 31, 2009 with supplemental funds awarded in the amount of**  
8 **\$71,480, for a total budget amount of \$142,960.00; and**

9 **WHEREAS, the FY 2009 STOP Project budget of \$71,480.00 was approved (for the fifth and final**  
10 **year) through Resolution No. 08-282; and**

11 **WHEREAS, the FY 2008 expenditures is over budget in the amount of \$14,431.70 resulting in the**  
12 **programs actual current budget in the amount of \$57,048.30 for FY 2009; and**

13 **WHEREAS, the Community Health Program will fund salaries and fringe benefits and the**  
14 **remaining estimated Consultant fees which fall within the scope of work of**  
15 **Community Health; and**

16 **WHEREAS, this budget amendment will re-allocate the savings in each budget line item as of May**  
17 **31, 2009 and increase line items Salaries, Fringe Benefits and Consultants.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**  
19 **the FY 2009 STOP Project Budget Amendment No. 1, account number 11-1478**  
20 **decreasing line items 620, 650, 660, 720, 721, 812, 850 and increases line items 610 and**  
21 **813, for a total budget of \$57,048.30, which will expire on 8/31/09.**

22 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
23 **Nation officials, to wit: the Chairman and Vice Chairman and any designated official**  
24 **are hereby authorized to negotiate and execute final program requirements and grant**  
25 **close out procedures.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 20<sup>TH</sup>. Day**  
27 **of AUGUST, 2009 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0-**  
28 **AGAINST; -0- NOT VOTING; and [03]ABSENT, pursuant to the powers vested in the Council by Section**  
29 **1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
30 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
31 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
32 **Stat. 984).**
