

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of the FY 2009 Tohono O'odham Department of Health and Human
Services, Division of Community Health Service Budget Amendment No.1)**

RESOLUTION NO. 09-464

1 **WHEREAS, the Division of Community Health Service (DCHS) is the umbrella Division and**
2 **oversees: Community Health Representatives, Home Health, Community Counseling**
3 **& Relations, Women, Infants and Children, Maternal and Child Health, Tuberculosis**
4 **Control and Prevention, Dialysis Patient Advisory Committee, O'odham in Mexico,**
5 **Motor Vehicle Injury Prevention, Family Violence Prevention, Violence Against**
6 **Women, Public Health Preparedness-BT, Cancer Awareness and Comprehensive**
7 **Cancer Control; and**

8 **WHEREAS, the Division of Community Health is part of the historically contracted Indian Health**
9 **Service functions and its program budget is incorporated into the Department of**
10 **Health and Human Service budget; and**

11 **WHEREAS, the FY 2009 Department of Health and Human Service budget was approved through**
12 **Resolution No. 08-271; and**

13 **WHEREAS, there are anticipated funding needs in mileage, lease/ rentals, professional services,**
14 **and other operational line items for a total \$57,042.87; and**

15 **WHEREAS, a new line item, 813 Consultants, was added to cover the STOP Motor Vehicle Injury**
16 **Prevention Project evaluation services; and**

17 **WHEREAS, the STOP Motor Vehicle Injury Prevention Project budget, in its final year of funding,**
18 **requires additional support in salary, fringe benefits; and**

19 **WHEREAS, there is a need to adjust the base funding amount by a decrease of \$4,744.00; and**

20 **WHEREAS, the net result of the fund redistribution is an overall budget decrease of \$6,145.33, due**
21 **to changes in the Professional Services and Major Capital line items which decreases**
22 **the indirect cost charges; and**

23 **WHEREAS, the Community Health Service new budget total budget moves from \$2,353,265.75 to**
24 **\$2,347,120.42, with an accompanying net decrease of \$1,401.33 in the indirect cost**
25 **charges for a revised IDC of \$354,026.76.**

26 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby:**

- 27 **1. Approves the Division of Community Health Service budget Amendment No. 1 for**
28 **a decrease of \$4,744.00 to the program base, with program operational fund**
29 **adjustments.**

- 1 2. Approves the new line item, 813 Consultants, added to cover the STOP Motor
2 Vehicle Injury Prevention Project evaluation services.
3 3. Approves the overall budget decrease of \$6,145.33 resulting from adjustments to
4 line items that affect the indirect cost charges.
5 4. Approves the \$1,401.33 decrease in the Indirect Cost Charges and the new budget
6 total of \$2,347,120.42.

7 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
8 Nation's official, to wit: the Chairman and Vice Chairman and any designated official
9 are authorized to administer and expend these funds, provided however, that any
10 amendments affecting the funds or funding levels of the contract shall be submitted
11 for further prior approval by the Tohono O'odham Legislative Council.

12 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 20TH. Day
13 of AUGUST, 2009 at a meeting at which a quorum was present with a vote of 2,390.8 FOR; -0-
14 AGAINST; -0- NOT VOTING; and 204.7 [04] ABSENT, pursuant to the powers vested in the Council by
15 Section 1 (d)(2)(3) and (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted
16 by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
17 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
18 18, 1934 (48 Stat. 984).
