

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Pisinemo District FY 2010 Budget)

RESOLUTION NO. 09-466

1 WHEREAS, Tohono O'odham Legislative Council Resolution No. 09-425 approved FY 2010 District
2 Allocation and Apportionment of Gaming Revenues to Districts by equal distribution;
3 and

4 WHEREAS, the Pisinemo District Council Representatives have presented its FY 2010 budget in the
5 amount of \$1,863,072.77 to its respective communities for review, comment and
6 recommendations; and

7 WHEREAS, the respective communities of Kupk/Dirtburn, Santa Cruz, Pisinemo and San Simon
8 have reviewed and supported the FY 2010 District Budget to be distributed as follows:

9	Salaries	\$ 664,731.79
10	Fringe Benefits	\$ 180,630.51
11	District Operations	\$ 897,710.47
12	Community Budgets	\$ 120,000.00
13	Community Development Financial Institution	\$ <u>35,333.33</u>
14	Total	\$1,863,072.77

15 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby
16 approve the Pisinemo District FY 2010 District Budget in the amount of \$1,863,072.77.

17 BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham
18 Nation's Officials to wit: the Chairman, Vice-Chairman and any designated official are
19 authorized to expend the budget, provided however, that any amendments affecting
20 the funds or funding levels of the budget shall be submitted for further prior approval.

21 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 20TH. Day
22 of AUGUST, 2009 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0-
23 AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by
24 Section 1 (d)(2) and (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by
25 the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
26 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
27 18, 1934 (48 Stat. 984).
