

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Pisinemo District FY 09 Budget Modification/Amendment No. 1)**

RESOLUTION NO. 09-467

1 **WHEREAS, Tohono O'odham Legislative Council Resolution No. 08-490 approved FY 2008-09**
2 **District Allocation and Apportionment of Gaming Revenues to Districts by equal**
3 **distribution; and**

4 **WHEREAS, Pisinemo District Council Resolution No. 08-P-19 supported the amount of**
5 **\$1,707,656.42 as the Pisinemo District FY 09 Budget; and**

6 **WHEREAS, the Pisinemo District Council at a regularly scheduled meeting on August 4, 2009**
7 **discussed modifying its 2009 District budget to cover over expenditures and**
8 **anticipated cost for the remainder of the fiscal year; and**

9 **WHEREAS, the Pisinemo District Administration submitted a proposal to modify its annual**
10 **operating budget to increase its Casual Labor line item by \$217.89; and**

11 **WHEREAS, the San Simon Community also submitted a proposal to modify its Community Budget**
12 **to decrease its Casual Labor line item by \$400.00; and**

13 **WHEREAS, the proposed budget modifications will either decrease or increase the line item**
14 **amounts budgeted for Casual Laborer positions in FY 09.**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
16 **approve the Pisinemo District FY 09 District Administration and San Simon**
17 **Community Budget Modification/Amendment No. 1.**

18 **BE IT FINALLY RESOLVED that any amendments affecting the funds or funding levels of this budget**
19 **shall be submitted to the Tohono O'odham Legislative Council for further prior**
20 **approval.**

21 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 20TH. Day**
22 **of AUGUST, 2009 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0-**
23 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**
24 **Section 1 (d)(2) and (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by**
25 **the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
26 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
27 **18, 1934 (48 Stat. 984).**
