

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving Sells Community Carry Over of 2<sup>nd</sup> Supplement from**  
**Fiscal Year 2008 to Fiscal Year 2009)**

**RESOLUTION NO. 09-469**

1 **WHEREAS, the Tohono O'odham Legislative Council Resolution No. 01-575 approved a \$500,000.00**  
2 **Supplemental Budget for the Sells District in Fiscal Year 2001; and**

3 **WHEREAS, the Sells District portioned out the supplement fund in the amount of \$58,000 to each**  
4 **of the four communities that make up the Sells District; and**

5 **WHEREAS, the Sells Community currently has a balance available of \$9,910.18 of the**  
6 **Supplemental Budget from Fiscal Year 2008 to be carried over into Fiscal Year 2009;**  
7 **and**

8 **WHEREAS, the attached budget and justification has been prepared and approved by Sells**  
9 **Community Resolution No. SC-19-09; and by Sells District Council Resolution No. SD-**  
10 **61-09.**

11 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
12 **carry over of \$9,910.18 from the balance of the Supplemental Budget for Sells**  
13 **Community from Fiscal Year 2008 to Fiscal Year 2009.**

14 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
15 **Sells District Chairperson and any designated District official to expend and**  
16 **administer the budget, as attached, provided that any modifications/amendments**  
17 **affecting the funds or funding levels of the budget shall be submitted for further prior**  
18 **approval by the Tohono O'odham Legislative Council.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 28<sup>TH</sup>. Day**  
20 **of AUGUST, 2009 at a meeting at which a quorum was present with a vote of 2,271.5 FOR; -0-**  
21 **AGAINST; -0- NOT VOTING; and 324.0[06] ABSENT, pursuant to the powers vested in the Council by**  
22 **Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
23 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
24 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
25 **18, 1934 (48 Stat. 984).**
