

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Sells District Administration FY 2009 Budget Amendment No. 1)**

RESOLUTION NO. 09-470

1 **WHEREAS, the Tohono O'odham Legislative Council Resolution No. 08-572 approved the Sells**
2 **District Administration Budget in the amount of \$1,707,656.42 from the Tohono**
3 **O'odham Nation's Gaming Revenues; and**

4 **WHEREAS, throughout FY2009 two of the communities Cowlic and North Communities had**
5 **submitted and received approval to carryover unexpended funds from FY2008 to**
6 **FY2009; and**

7 **WHEREAS, Tohono O'odham Legislative Council Resolution No. 09-039 approved the carryover of**
8 **\$11,192.61 for North Communities; and Tohono O'odham Legislative Council**
9 **Resolution No. 09-118 approved the carryover of \$18,275.83 for Cowlic Community;**
10 **and**

11 **WHEREAS, both of these amounts increased the total budget for the Sells District Administration**
12 **FY2009 to a total of \$1,737,124.86; and**

13 **WHEREAS, the attached budget amendment and its justification was reviewed and approved by**
14 **all of the four communities and brought forward to the Sells District Council for**
15 **approval with Resolution No. SD-62-09; and**

16 **WHEREAS, the budget Amendment will decrease Salaries Line Item #610 by \$54,716.07 and Line**
17 **Item #620 Fringe Benefits by \$16,414.82 for a total decrease of \$71,130.89 which will be**
18 **carried over to Line Item #727 Building Materials in the full amount.**

19 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
20 **Sells District Administration Fiscal Year 2009 Budget Amendment No.1 which will**
21 **decrease Line Item #610 Salaries by \$54,716.07 and Line Item #620 Fringe Benefits by**
22 **\$16,414.82 and will increase Line Item #727 Building Materials by \$71,130.89 of the**
23 **current Fiscal Year 2009 budget which is \$1,737,124.86 from Gaming Revenues.**

24 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
25 **Sells District Chairperson and any designated District official to expend and**
26 **administer the budget according to its justification as attached, provided that any**
27 **modifications/amendments affecting the funds or funding levels of the budget shall**
28 **be submitted for further prior approval by the Tohono O'odham Legislative Council.**

29 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 28TH Day**
30 **of AUGUST, 2009 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0-**
31 **AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by**
32 **Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
33 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
34 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
35 **18, 1934 (48 Stat. 984).**
