

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving and Appropriating \$20,575.00 for the Tohono O'odham Nation
Magdalena Visitor Center Project)**

RESOLUTION NO. 09-471

1 WHEREAS, the Tohono O'odham Nation has historically funded the "Magdalena Visitor Center
2 Project" for the purposes of assisting members of the Nation during their travel to
3 Magdalena, Sonora Mexico; and

4 WHEREAS, the Chairman and Vice Chairman of the Tohono O'odham Nation have determined it
5 to be prudent for the Tohono O'odham Nation to have this project funded through
6 existing surplus funding; and

7 WHEREAS, the Office of the Treasurer has provided that there remains existing surplus funds to
8 cover the Tohono O'odham Nation Magdalena Visitor Center Project Budget.

9 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby
10 approve the Tohono O'odham Nation Magdalena Visitor Center Project budget in the
11 form attached hereto and appropriates \$20,575.00 from the existing FY 2009 Surplus
12 funding to fund this budget, such funds shall remain available for expenditure from
13 the effective date of this resolution through October 30, 2009.

14 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 28TH. Day
15 of AUGUST, 2009 at a meeting at which a quorum was present with a vote of 2,493.15 FOR; 102.35
16 AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by
17 Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the
18 Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
19 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
20 18, 1934 (48 Stat. 984).


