

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving Second No Cost Extension of the U.S. Department of Homeland Security,**  
**Federal Emergency Management Agency 2006 Assistance to Firefighters Grant No.**  
**EMW-2006-FG-18408)**

RESOLUTION NO. 09-473

1 **WHEREAS, the United States Department of Homeland Security has distributed grants to local fire**  
2 **departments through the Federal Emergency Management Agency's Assistance (FEMA)**  
3 **to Firefighters Grant Program to assist in providing public safety services within their**  
4 **respective jurisdictions; and**

5 **WHEREAS, the Tohono O'odham Nation has been awarded a grant to purchase dispatch software**  
6 **and communication equipment on a reimbursed match basis of ninety-five percent**  
7 **from Federal funds (no more than \$89,775.00) and five percent from the recipient**  
8 **(Tohono O'odham Nation); and**

9 **WHEREAS, the Tohono O'odham Nation Fire Department has allocated the five percent share of**  
10 **\$4,725.00 within the Department's Fiscal Year 2008 Budget; and**

11 **WHEREAS, the Tohono O'odham Legislative Council approved acceptance of this grant and the FY**  
12 **2008 budget by TOLC Resolution No. 08-533; and**

13 **WHEREAS, the original performance period of this grant ended on September 20, 2008; and a**  
14 **grant extension was requested and approved by FEMA; and**

15 **WHEREAS, the Tohono O'odham Legislative Council approved the extension of the Assistance to**  
16 **Firefighters Grant No. EMW-2006-FG-18408 through June 25, 2009 and further**  
17 **approved the carryover of funds from account number 11-1089 from FY 2008 to FY**  
18 **2009 by TOLC Resolution No. 09-239; and**

19 **WHEREAS, the Tohono O'odham Nation Fire Department has allocated the five percent share of**  
20 **\$4,725.00 within the Department's Fiscal Year 2009 Budget; and**

21 **WHEREAS, a second extension has been requested and approved by FEMA extending the grants**  
22 **performance period through September 21, 2009; and**

23 **WHEREAS, the second no cost extension request for extending project period through September**  
24 **21, 2009 and carry forward budget request of \$89,775.00 from account number 11-1089**  
25 **has been reviewed and approved by the Office of Grants and Contracts, Executive**  
26 **Office, Domestic Affairs Committee, Budget & Finance Committee, and the**  
27 **forementioned offices and committees recommend approval by the Legislative**  
28 **Council.**

7 **BE IT FINALLY RESOLVED that any amendment affecting the funding or funding levels be**  
8 **submitted for further prior approval to the Tohono O'odham Legislative Council.**

9 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 28<sup>TH</sup>. Day**  
10 **of AUGUST, 2009 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0-**  
11 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**  
12 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
13 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
14 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
15 **Stat. 984).**


