

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Gu Achi District's Fiscal Year 2010 Budget of \$1,863,072.77)**

RESOLUTION NO. 09-475

1 WHEREAS, the Tohono O'odham Legislative Council did convene on September 2, 2009 to
2 address issues pertaining to the Nation; and
3 WHEREAS, the Tohono O'odham Nation Legislative Council approved Resolution #09-
4 425 "Approving FY 2010 District Allocation and Apportionment of Gaming Revenues
5 to Districts by Equal Distribution"; and
6 WHEREAS, the Gu Achi District's allocation is in the amount of \$1,863,072.77 for Fiscal Year
7 2010; and
8 WHEREAS, the Gu Achi District Council passed Resolution #0809-060 for approval of the Fiscal
9 Year 2010 Budgets for the District's Administration and Communities for
10 operational and direct services to meet the needs of the District and Communities;
11 and
12 WHEREAS, the Gu Achi District Fiscal Year 2010 budget was presented, reviewed and
13 recommended for approval by the Nation's Budget & Finance Committee.
14 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Nation Legislative Council hereby
15 approves the Gu Achi District's Fiscal Year 2010 Budget in the amount of
16 \$1,863,072.77 as attached hereto.
17 BE IT FURTHER RESOLVED that any additional funds coming to the Gu Achi District will
18 automatically be deposited to the District's Savings Account.
19 BE IT FINALLY RESOLVED that the Gu Achi District Council has the authority to modify its Fiscal
20 Year 2010 budget in accordance with protocols set forth by this Council. Any
21 amendments affecting the funds or funding levels of the Gu Achi District's Fiscal
22 Year 2010 budget shall be approved by the Tohono O'odham Legislative Council.
23 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 02ND. Day
24 of SEPTEMBER, 2009 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0-
25 AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by
26 Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the
27 Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
28 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
29 18, 1934 (48 Stat. 984).
