

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(To Amend Enrollment Resolution No. 349-86)**

**RESOLUTION NO. 09-478**

1 **WHEREAS, the Legislative Council is vested with the power to “enact laws and Ordinances for**  
2 **governing the enrollment and adoption of members and the Relinquishment and loss**  
3 **of membership” (Constitution of the Tohono O’odham Nation, Article VI, Section 1 (b);**  
4 **and**

5 **WHEREAS, Article VIII, Section 1 of the Enrollment Ordinance, Ordinance 05-81 (as amended)**  
6 **provides that the Legislative Council shall determine applicant’s eligibility for**  
7 **enrollment or Adoption; and**

8 **WHEREAS, on July 02, 1986 the Legislative Council, pursuant to Resolution No. 349-86, approved**  
9 **Katrina M. Conde for membership in the Tohono O’odham Nation; and**

10 **WHEREAS, the Enrollment Committee has determined, based on the individual’s date of birth,**  
11 **and family tree, that Katrina M. Conde listed with Roll No. 2834-S-86 was given the**  
12 **same number assigned to another member; (Nikki L. Salazar pursuant to Resolution**  
13 **No. 260-86) and**

14 **WHEREAS, the Enrollment Manual at page 5, (Filing of applications) provides that once a number**  
15 **has been assigned to an application it shall not be changed; and**

16 **WHEREAS, Article X, Section 3 of the Enrollment Ordinance provides that the Tohono O’odham**  
17 **Legislative Council shall cause the membership roll to be kept current.**

18 **NOW THEREFORE BE IT RESOLVED THAT:**

- 19 **1. The Tohono O’odham Legislative Council approves a modification of Resolution**  
20 **No. 349-86 as follows:**  
21 **The Roll No. listed for Nikki L. Salazar shall retain the Roll# 2834-S-86, The Roll No.**  
22 **listed for Katrina M. Conde shall be changed to 2839-S-86 to reflect the number**  
23 **originally assigned to application of Katrina M. Conde on July 02, 1986 which was**  
24 **approved by this Council pursuant to Resolution No. 349-86.**
- 25 **2. The Enrollment Committee shall make the necessary changes in the records of the**  
26 **Enrollment office to incorporate the stated modification.**

27 **The foregoing Resolution was passed by the Tohono O’odham Legislative Council on the 14<sup>TH</sup>. Day**  
28 **of SEPTEMBER, 2009 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0-**  
29 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Article**  
30 **Section 1 of Article II and Section 1(h) of Article VI of the Constitution of the Tohono O’Odham**  
31 **Nation, adopted by the Tohono O’Odham Nation on January 18, 1986; and approved by the Acting**  
32 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16**  
33 **of the Act of June 18, 1934 (48 Stat. 984).**
