(Approving and Accepting the Arizona Governor's Office of Highway Safety contract
2008-AI-001 and budget in the amount of \$59,000.00)

RESOLUTION NO. 09-485

1 **WHEREAS, the Tohono O'odham Nation Police Department (TONPD) has been awarded the**
2 **Arizona Governor's Office of Highway Safety contract in the amount of \$59,000.00; and**

3 **WHEREAS, this contract is for the purpose of conducting accident investigations throughout the**
4 **Tohono O'odham Nation; and**

5 **WHEREAS, the contract is for support of Travel-Out-of State for training purposes and for**
6 **purchase of one crash data retrieval system and one globe positioning system to**
7 **conduct the accident investigations; and**

8 **WHEREAS, this contract is effective from May 1, 2009 thru September 30, 2009; and**

9 **WHEREAS, under the FY 2009 Proposal guide it is the policy of the GOHS not to fund indirect cost;**
10 **and**

11 **WHEREAS, a budget has been attached with line items 660 Travel, 650 Registration/Tuition and**
12 **750 Capital.**

13 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**
14 **accepts and approves the contract with the Arizona State Governor's Office of Highway**
15 **Safety and authorizes the budget attached in the amount of \$59,000.00 effective May**
16 **1, 2009 thru September 30, 2009 with no Indirect cost as required in the FY 2009**
17 **proposal guide.**

18 **BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council hereby authorizes the**
19 **Chairman of the Nation to sign and execute the contract with the Arizona State**
20 **Governor's Office of Highway Safety.**

21 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that it hereby authorizes the**
22 **Chairperson and any designated official to execute the contract and expend and**
23 **administer the budget as attached, provided that any amendments affecting the funds**
24 **or funding level shall be submitted for further prior approval by the Tohono O'odham**
25 **Legislative Council.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 14TH. Day**
27 **of SEPTEMBER, 2009 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0-**
28 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
29 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
30 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
31 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
32 **Stat. 984).**
