

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2009 Budget Amendment No. 2 for the Tohono O'odham Nation Police Department BIA 638 Contract in the amount of \$801,273.21 changing budget amount from \$3,447,050.58 to \$4,403,370.17)**

RESOLUTION NO. 09-486

1 WHEREAS, the Tohono O'odham Nation contracts its own Law Enforcement, Ranger and  
2 Corrections Programs under the 638 BIA Master Contract; and

3 WHEREAS, the Tohono O'odham Nation Police Department (TONPD) has carry over savings from  
4 FY 2005 and adjustments from FY 2009 in the amount of \$801,273.21; and

5 WHEREAS, the TONPD has increased line items 712 Gas, oil & coolants and 723 Uniforms; and

6 WHEREAS, the TONPD has created new line item 630 Insurance to cover the annual cost of the  
7 Public Safety Personnel Retirement System Cancer insurance in the amount of  
8 \$3,000.00, 771 Repair & Maintenance of Vehicles, and 850 Food; and

9 WHEREAS, the total cost of these increases and new lines total the amount of \$801,273.21.

10 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby  
11 approves and authorizes Budget Amendment No. 2 in the amount of \$801,273.21 carry  
12 over savings for the Tohono O'odham Nation Police Department as the following:

13 1) Increase to line items 712 Gas, oil & Coolant, 723 Uniforms.

14 2) Creations of new line items 630 Insurance for the annual Public Safety Personnel  
15 Retirement System annual cost for cancer insurance, 771 Repair & Maintenance  
16 of vehicles, and 850 Food.

17 3) Increasing budget by \$801,273.21 with indirect cost at \$155,046.37 for a total  
18 amount of \$956,319.58.

19 BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that it hereby authorizes the  
20 Chairman and any designated official to expend and administer the budget as  
21 attached, provided that any amendments affecting the funds or funding level shall be  
22 submitted for further prior approval by the Tohono O'odham Legislative Council.

23 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 14<sup>TH</sup>. Day  
24 of SEPTEMBER, 2009 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0-  
25 AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by  
26 Section 1 (d)(3) and (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by  
27 the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
28 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
29 18, 1934 (48 Stat. 984).
