1 **WHEREAS, the Low Income Home Energy Assistance (LIHEAP) is funded on a year to year basis by**
2 **the Arizona Department of Economic Security, through an Intergovernmental**
3 **Agreement, Contract No. E6306018; and**

4 **WHEREAS, amendment no. 6 to the Intergovernmental Agreement has been received, adding**
5 **funding for the period beginning July 01, 2009 to June 30, 2010; and**

6 **WHEREAS, the contract reimbursement ceiling for the services Case Management is \$62,752.00;**
7 **and**

8 **WHEREAS, the Itemized Service Budget for the services Case Management is added and attached**
9 **to Amendment No. 6 as Attachment A; and**

10 **WHEREAS, the Executive Branch developed and obtained committee approval of Amendment No.**
11 **6 of the Intergovernmental Agreement to add funding in the amount of \$62,572.00 for**
12 **the period beginning July 01, 2009 to June 30, 2010, and adding the Itemized Service**
13 **Budget.**

14 **NOW, THEREFORE BE, IT RESOLVED that the Tohono O'odham Legislative Council approves and**
15 **authorizes the Family Assistance Division, Low Income Home Energy Assistance**
16 **(LIHEAP) Department of Economic Security, Amendment No. 6 of the**
17 **Intergovernmental Agreement to add funding in the amount of \$62,572.00 for the**
18 **period beginning July 01, 2009 to June 30, 2010, and adding the Itemized Service**
19 **Budget.**

20 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council authorizes and directs the**
21 **Chairperson, to sign, administer and execute Amendment No. 6, in substantially the**
22 **form attached hereto; provided however that any amendments affecting the contract**
23 **amount shall be submitted for further prior approval by the Tohono O'odham**
24 **Legislative Council.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 14TH. Day**
26 **of SEPTEMBER, 2009 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0-**
27 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
28 **Section 1 (d)(2)(3) & (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by**
29 **the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
30 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
31 **18, 1934 (48 Stat. 984).**
