**(Approving Department of Health and Human Services, Division of Family Assistance – FY2010 Low Income Home Energy Assistance Program (LIHEAP) Budget Amendment #1, Account No. 12-1310)**

**RESOLUTION NO. 09-491**

1 **WHEREAS, by Resolution Number 09-284 the Tohono O'odham Legislative Council approved the**  
2 **FY2010 Low Income Home Energy Assistance Program budget in the amount of**  
3 **\$38,390.00; and**

4 **WHEREAS, the Tohono O'odham Nation's award for FY2010 funding through the State of Arizona,**  
5 **Department of Economic Security, Community Services Administration for contract**  
6 **period July 01, 2009 through June 30, 2010 was increased from \$38,390.00 to**  
7 **\$62,572.00; and**

8 **WHEREAS, the Tohono O'odham Department of Health and Human Services, Family Assistance**  
9 **Division, Low Income Home Energy Assistance Program (LIHEAP) has submitted the**  
10 **attached FY2010 LIHEAP Budget Amendment #1 which increases Line Item 858 -**  
11 **LIHEAP Payments at \$58,818.00, and decreases Line Items: 720 Supplies at \$3,145.37**  
12 **and 900 - Indirect Cost at \$608.63 for a total budget of \$62,572.00; and**

13 **WHEREAS, the Executive Branch developed and obtained committee approval of the Family**  
14 **Assistance Division, Low Income Home Energy Assistance Budget Amendment #1**  
15 **which increases Line Item 858 - LIHEAP Payments at \$58,818.00, and decreases Line**  
16 **Items: 720 Supplies at \$3,145.37 and 900 - Indirect Cost at \$608.63 for a total budget**  
17 **of \$62,572.00 to be effective July 01, 2009 through June 30, 2010.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**  
19 **approve FY2010 budget amendment #1 which reflects the final award amount of**  
20 **\$62,572.00 and authorizes the Executive Branch to expend funds in the attached**  
21 **LIHEAP Budget Amendment #1 effective July 01, 2009 through June 30, 2010. Budget**  
22 **Amendment #1 increases Line Item 858 - LIHEAP Payments at \$58,818.00, and**  
23 **decreases Line Items: 720 Supplies at \$3,145.37 and 900 - Indirect Cost at \$608.63 for**  
24 **a total budget of \$62,572.00.**

25 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
26 **Chairperson, and any designated official to expend and administer budget**  
27 **amendment #1 as attached, provided that any amendments affecting the funds or**  
28 **funding level shall be submitted for further prior approval by the Tohono O'odham**  
29 **Legislative Council.**
