

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving the San Xavier District Budget for Fiscal Year 2010)**

**RESOLUTION NO. 09-495**

1 **WHEREAS, the San Xavier District Council reviewed the projected expenditures for its FY 2010**  
2 **budget and determined that the budget components are essential to meeting the**  
3 **needs of the San Xavier District Community; and**

4 **WHEREAS, the San Xavier District Council intends to utilize its gaming and general operating**  
5 **funds to meet the projected budget amount outlined in the attached fiscal year 2010**  
6 **budget; and**

7 **WHEREAS, the proposed budget of \$7,450,897.69 was reviewed and approved by majority vote of**  
8 **the San Xavier District members present at the Special District Community meeting**  
9 **held on August 22, 2009; and**

10 **WHEREAS, the San Xavier District officials and staff met with the Legislative Budget & Finance**  
11 **Committee on September 9, 2009 to review the District's budget and supporting**  
12 **resolution.**

13 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**  
14 **the San Xavier District's FY10 budget in the amount of \$7,450,897.69 utilizing**  
15 **\$6,947,491.56 of its gaming revenues and \$34,124.22 from its reserves to implement its**  
16 **budget.**

17 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 15<sup>TH</sup>. Day**  
18 **of SEPTEMBER, 2009 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0-**  
19 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**  
20 **Section 1 (d)(2)&(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
21 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
22 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
23 **18, 1934 (48 Stat. 984).**
