

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval to Display Tohono O'odham Nation Poster in the Lobby of the Pima
County Administration Building Located at 130 W. Congress, Tucson, Arizona)**

RESOLUTION NO. 09-498

1 **WHEREAS, the Pima County Cultural Resources & Historic Preservation Office approached the**
2 **Tohono O'odham Nation to help develop a poster about the culture and history of the**
3 **Tohono O'odham Nation; and**

4 **WHEREAS, the Pima County Cultural Resources & Historic Preservation Office approached the**
5 **Tohono O'odham Nation, the Pascua Yaqui Tribe, and all incorporated municipalities**
6 **located in Pima County to develop posters to be displayed in the lobby of the Pima**
7 **County Administration Building; and**

8 **WHEREAS, the Nation agreed to develop the Tohono O'odham Nation poster with the Cultural**
9 **Preservation Legislative Committee taking the lead for the development of the poster;**
10 **and**

11 **WHEREAS, the Cultural Preservation Legislative Committee worked with Allison Francisco, of the**
12 **Tohono O'odham Nation Cultural Center & Museum, to design and present working**
13 **versions to the Cultural Preservation Legislative Committee for review and comment;**
14 **and**

15 **WHEREAS, Allison Francisco, Tohono O'odham Nation Cultural Center & Museum worked with**
16 **the Pima County Cultural Resources & Historic Preservation Office to draft the layout**
17 **of the poster for presentation to the Cultural Preservation Legislative Committee for**
18 **review and comment; and**

19 **WHEREAS, the Pima County Cultural Resources & Historic Preservation has incorporated all of**
20 **the photographs, artwork, text, comments, and corrections into the production of a**
21 **final version of the Tohono O'odham Nation poster; and**

22 **WHEREAS, the Cultural Preservation Legislative Committee has reviewed and approved the final**
23 **version of the Tohono O'odham Nation poster for presentation and approval by the**
24 **Tohono O'odham Legislative Council.**

25 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
26 **the display of the Tohono O'odham Nation poster in the lobby of the Pima County**
27 **Administration Building located at 130 W. Congress, Tucson, Arizona.**

28 **BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council and the Pima County**
29 **Cultural Resources & Historic Preservation Office will hold a dedication for the display**
30 **of the Tohono O'odham poster at 10 am on November 20, 2009 in the lobby of the Pima**
31 **County Administration Building.**

32 **BE IT FINALLY RESOLVED that any future revisions to the Tohono O'odham Nation poster shall be**
33 **submitted for further approval by the Tohono O'odham Legislative Council.**
