

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving of the Gu-Vo District Fiscal Year 2010 Budgets for the Administration and**  
**Gu-Vo; Ali Chugk; Pia-Oik; and Kukatch Communities in the amount of \$2,053,415.66)**

**RESOLUTION NO. 09-500**

1 **WHEREAS, the Gu-Vo District Governing Council did receive the allocated amount of**  
2 **\$1,863,072.77 from the Tohono O'odham Nation Gaming Revenue Distributions given**  
3 **out to all the 11 Districts in equal amount; and**

4 **WHEREAS, the amount of \$1,863,072.77 from the Tohono O'odham Nation's Gaming Revenue has**  
5 **been allocated to the communities in the amount of \$253,101.58 per community and**  
6 **the Administration at \$850,666.42; and**

7 **WHEREAS, Pursuant to Resolution GV09-136 "Approving of Gu-Vo District Administration to Carry**  
8 **Over Remaining Funds from Fiscal Year 2006 into Fiscal Year 2010" amount of**  
9 **\$190,342.92 and the funds shall be included in the Gu-Vo District's FY' 2010 Budget;**  
10 **and**

11 **WHEREAS, the Administration's total budget amount for FY' 2010 is \$1,041,009.34; and**

12 **WHEREAS, the Gu-Vo District did present to its membership the budgets of the Administration,**  
13 **Communities, and also to the Governing Council for review and approval; and**

14 **WHEREAS, the Gu-Vo District Governing Council has approved the budget allocation for each**  
15 **community and Administration, and they are as follows:**

22 **WHEREAS, the Gu-Vo District Governing Council did approve the FY' 2010 budgets for the**  
23 **Administration and communities, per attached resolutions.**

24 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**  
25 **the Gu-Vo District FY' 2010 Budget in the amount of Two Million Fifty Three Thousand**  
26 **Four Hundred Fifteen Dollars and Sixty Six Cents (\$2,053,415.66) of which \$1,863,072.77**  
27 **of Gaming Distribution and the \$190,342.92 of Fiscal Year 2006 carryover funds.**

28 **BE IT FINALLY RESOLVED that the Gu-Vo District reserves the right to modify its Fiscal Year 2010**  
29 **Budget according to the Tohono O'odham Nation's process, but any amendments**  
30 **affecting the funds or funding levels shall be approved by the Legislative Council.**


