(Approving Amendment No. 2 to Attorney Contract with the Law Firm of
Gammage and Burnham)


1 **WHEREAS, by Resolution No. 09-201 the Nation approved an Attorney Contract in the amount of**
2 **\$20,000 with the law firm of Gammage and Burnham, P.L.C., funded by an Office of**
3 **Attorney General budget amendment approved by Resolution No. 09-160; and**
4 **WHEREAS, by Resolution No. 09-396, the Nation approved Amendment No. 1 to the Attorney**
5 **Contract, which added \$100,000 to the budget for the Attorney Contract; and**
6 **WHEREAS, the Attorney General recommends approval of Amendment No. 2 to the Attorney**
7 **Contract, which adds \$75,000 to the budget for the Attorney Contract; and**
8 **WHEREAS, the Domestic Affairs and Budget and Finance Committees have reviewed Amendment**
9 **No. 2 to the Attorney Contract and recommend approval by the Legislative Council.**

10 **NOW, THEREFORE, BE IT RESOLVED that:**

- 11 **1. The Tohono O'odham Legislative Council hereby approves Amendment No. 2 to the**
12 **Attorney Contract with the law firm of Gammage and Burnham, P.L.C., which adds**
13 **\$75,000 to the budget for the Attorney Contract, substantially in the form attached**
14 **hereto.**
- 15 **2. Funding for Amendment No. 2 to the Attorney Contract will come from the**
16 **\$220,000.00 for professional services approved and appropriated by Resolution No.**
17 **09-160 as Amendment No. 1 to the budget of the Office of Attorney General.**
- 18 **3. The Chairperson of the Nation is authorized and directed to execute Amendment**
19 **No. 2 to the Attorney Contract with the law firm of Gammage and Burnham, P.L.C.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 16TH. Day**
21 **of SEPTEMBER, 2009 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0-**
22 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
23 **Section 2 (a) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
24 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
25 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
26 **18, 1934 (48 Stat. 984).**


