

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving Amendment 1 to the Water Resources Department FY10 budget 21-1525 to**  
**Use additional interest from the Southern Arizona Water Rights Settlement Act**  
**Trust Fund in the amount of \$427,678.46, for a total budget of \$1,844,121.44)**

**RESOLUTION NO. 09-502**

1 **WHEREAS, the Tohono O'odham Legislative Council approved the Water Resources Department**  
2 **FY10 budget 21-1525 through Resolution 09-298, in the amount of \$1,416,442.98; and**

3 **WHEREAS, the Water Resources Department is requesting the approval of amendment 1 to the**  
4 **FY10 budget 21-1525 to use additional interest from the Southern Arizona Water Rights**  
5 **Settlement Act Trust Fund, in the amount of \$427,678.46, for a total budget of**  
6 **\$1,844,121.44; and**

7 **WHEREAS, the Water Resources Department also requesting that the additional funding be used**  
8 **to increase salaries and fringe benefits, by \$93,746.70, to add an Assistant Director to**  
9 **the Departmental personnel, to increase capital equipment, by \$332,850.00, to**  
10 **purchase two new water trucks, and to increase insurance by \$1,081.76; and**

11 **WHEREAS, amendment 1 to the FY10 budget 21-1525 has been reviewed by the Legislative Water**  
12 **Resources Committee and the Budget and Finance Committee.**

13 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**  
14 **approves amendment 1 to the Water Resources Department FY10 budget 21-1525 to:**

- 15 **1. Use additional interest from the Southern Arizona Water Rights Settlement Act**  
16 **Trust Fund, in the amount of \$427,678.46, for a total budget of \$1,844,121.44.**  
17 **2. To use the additional funding to increase salaries and fringe benefits, by**  
18 **\$93,746.70, to add an Assistant Director to the Departmental personnel, to increase**  
19 **capital equipment, by \$332,850.00, to purchase two new water trucks, and to**  
20 **increase insurance by \$1,081.76, in accordance with the budget attached hereto.**

21 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
22 **Chairperson and any designated official to expend and administer the budget, as**  
23 **attached, provided that any amendments affecting the funds or funding levels of the**  
24 **budget shall be submitted for further prior approval by the Tohono O'odham**  
25 **Legislative Council.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 16<sup>TH</sup>, Day**  
27 **of SEPTEMBER, 2009 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0-**  
28 **AGAINST; -01- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**  
29 **Section 1 (f(i)) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
30 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
31 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
32 **18, 1934 (48 Stat. 984).**
