RESOLUTION NO. 09-503

1 **WHEREAS, the Department of Health and Human Services, Division of Management of Health**
2 **directs services that provide substance abuse, mental health, and prevention services;**
3 **and**

4 **WHEREAS, the Division of Management of Health submitted an application on or about November**
5 **6, 2008, to the U.S. Department of Health and Human Services/Substance Abuse and**
6 **Mental Health Services Administration Center for Substance Abuse Prevention for a**
7 **Strategic Prevention Framework Tribal Incentive Grant to design and implement a**
8 **Tohono O'odham Nation Strategic Plan establish prevention programs within each**
9 **District to reduce substance abuse and related health problems that include suicide,**
10 **diabetes, depression, fetal alcohol syndrome and premature death rates; and**

11 **WHEREAS, the Notice of Award was received on July 10, 2009 for a grant in the amount of**
12 **\$600,800.00 for the first budget year period from July 1, 2009 through June 30, 2010, for**
13 **Year One of a five-year grant for a total amount of \$3,004,000.00; and**

14 **WHEREAS, of the total grant amount of \$600,800.00 the budget for Year One reflects the current**
15 **indirect costs of 19.35% in the amount of \$59,630.75; and**

16 **WHEREAS, the first year award in the amount \$600,800.00 was reviewed and approved by**
17 **Oversight and Budget & Finance Committees and is hereby submitted for review and**
18 **approval by the Tohono O'odham Legislative Council.**

19 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council:**

- 20 **1. The Notice of Award was received on July 10, 2009 for grant in the amount of**
21 **\$600,800.00 for the first budget year period from July 1, 2009 through June 30, 2010,**
22 **for Year One of the a five-year grant for a total amount of \$3,004,000.00.**
- 23 **2. Hereby approves and authorizes expenditures for a SAMHSA-funded Strategic**
24 **Prevention Framework Tribal Incentive Grant as stated in the attached budget in**
25 **the amount of \$600,800.00 of which \$ 59,630.75 is for indirect costs at 19.35%, for**
26 **the first year of a five year grant.**

27 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
28 **Chairperson and any designated official to expend and administer the budget as**
29 **attached, provided that any amendments affecting the funds or funding level shall be**
30 **submitted for further prior approval by the Tohono O'odham Legislative Council.**




