RESOLUTION NO. 09-504

1 **WHEREAS, the Tohono O'odham Nation Department of Health and Human Services, Division of**  
2 **Senior Services has been awarded \$16,610.00 from the Administration on Aging Title**  
3 **VI, American Recovery and Reinvestment Act (ARRA) grant to fund programs as**  
4 **authorized; and**

5 **WHEREAS, this funding source will be utilized to match the 20% requirement for the Senior**  
6 **Services Division to obtain two new handicap accessible vehicles ordered under the**  
7 **State 5310 program.**

8 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**  
9 **the budget that as attached for capital outlay expense in the amount of \$16,610.00.**

10 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
11 **Nation officials, to wit: the Chairman and Vice Chairman and any designated official**  
12 **are hereby authorized to negotiate and execute the grant, provided however, that any**  
13 **amendments affecting the funds or funding levels of the grant shall be submitted for**  
14 **further prior approval by the Tohono O'odham Legislative Council.**

15 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 16<sup>TH</sup>. Day**  
16 **of SEPTEMBER, 2009 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0-**  
17 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**  
18 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
19 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
20 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
21 **Stat. 984).**
